F-25-01/07

Approve a notice of intent to adopt the resolution authorizing the front-end referendum question and the resolution authorizing the Board to assess and levy the Act 1 income tax, along with information on the public hearing. Record vote for the motion: Banks, Chobany, Penna, Stewart, and Vamos. Against the motion: None. Abstained: None. Absent: Blue, Eisenhuth, Jones, and Lucas. The motion carried.

F-26-01/07

Approve a resolution authorizing the front-end referendum question as follows:

Do you favor the Ferndale Area School District imposing an additional .5% earned income tax? The revenue generated from the tax increase will be used to reduce taxes on qualified owner occupied residential properties and on qualified farm buildings by approximately \$185.00. The current school district earned income and net profits tax rate is .5%, and the current combined municipal/school district rate is 1%. If approved, the new combined rate would be 1.5%.
