DELINQUENT COST RESOLUTION

A RESOLUTION OF THE GOVERNING BOARD OF FERNDALE AREA SCHOOL DISTRICT, CAMBRIA COUNTY, PENNSYLVANIA, AUTHORIZING AND EMPOWERING ITS LOCAL TAX COLLECTOR, BERKHEIMER, TO IMPOSE AND RETAIN COSTS OF COLLECTION ON DELINQUENT TAXES.

WHEREAS, FERNDALE AREA SCHOOL DISTRICT, CAMBRIA COUNTY, by Resolution, has levied, assessed and provided for the collection of certain local taxes under and pursuant to the authority of the Act No. 511 of the 1965 General Assembly of the Commonwealth of Pennsylvania, enacted December 31, 1965, and effective January 1, 1966, as amended; and

WHEREAS, FERNDALE AREA SCHOOL DISTRICT, CAMBRIA COUNTY, has hired Berkheimer to collect said taxes levied by the FERNDALE AREA SCHOOL DISTRICT, CAMBRIA COUNTY, including taxes that are or may become delinquent; and

WHEREAS, pursuant to Act 192 of the 2003-2004 General Assembly of the Commonwealth of Pennsylvania, FERNDALE AREA SCHOOL DISTRICT, CAMBRIA COUNTY, has the right to impose a cost of collection on taxes that become delinquent and/or that remain due and unpaid;

NOW, THEREFORE, BE IT RESOLVED that

1. FERNDALE AREA SCHOOL DISTRICT, CAMBRIA COUNTY APPROVES AND ADOPTS the Cost of Collection Schedule attached hereto and made apart of this Resolution to be imposed by BERKHEIMER upon any taxpayer whose taxes are or become delinquent and/or remain due and unpaid.
2. BERKHEIMER is authorized to retain said costs of collection set forth in the attached schedule incurred in recovering delinquent taxes and assessed to the delinquent taxpayer as allowed by law.
3. Any resolution or part of this resolution conflicting with the provisions of this resolution be and the same are hereby repealed to the extent of such conflict.

A RESOLUTION OF THE GOVERNING BOARD OF FERNDALE AREA SCHOOL DISTRICT, CAMBRIA COUNTY, PENNSYLVANIA, AUTHORIZING, EMPOWERING AND DIRECTING THE PROPER OFFICERS OF THE GOVERNING BOARD TO APPOINT A LIAISON BETWEEN IT AND BERKHEIMER, THE DULY APPOINTED COLLECTOR OF EARNED INCOME TAX FOR THE DISTRICT, FOR THE EXPRESS PURPOSE OF SHARING CONFIDENTIAL TAX INFORMATION WITH THE DISTRICT FOR OFFICIAL PURPOSES.

WHEREAS, Act No. 511 of the 1965 General Assembly of the Commonwealth of Pennsylvania (53 P.S. §6901 et seq.), enacted December 31, 1965, and effective January 1, 1966, authorizes certain political subdivisions, including FERNDALE AREA SCHOOL DISTRICT, CAMBRIA COUNTY, to provide for the creation of such bureaus or the appointment and compensation of such officers, clerks, collectors and other assistants and employees as may be deemed necessary for the assessment and collection of taxes imposed under the authority of that Act; and

WHEREAS, FERNDALE AREA SCHOOL DISTRICT, CAMBRIA COUNTY, has entered into contractual agreement with BERKHEIMER of Bangor, Pennsylvania, whereby and whereunder CLIENT appointed Berkheimer to collect Earned Income Tax; and

WHEREAS, said Act 511 specifically mandates that any information gained by the appointed tax officer, his agents or by any other official or agent of the taxing district, as a result of any declarations, returns, investigations, hearings or verifications required or authorized by the taxing municipality's ordinance or resolution, be kept confidential, except for official purposes; and

WHEREAS, any person who divulges any information which is confidential under the provisions of any ordinance or resolution, upon conviction may be subject to fines and/or imprisonment, upon conviction, and dismissal from office or discharge from employment; and

A RESOLUTION OF FERNDALE AREA SCHOOL DISTRICT, CAMBRIA COUNTY, ESTABLISHING, MODIFYING AND REENACTING AN EARNED INCOME TAX FOR RESIDENTS OF THE FERNDALE AREA SCHOOL DISTRICT

WHEREAS, Act No. 511 of the 1965 General Assembly of the Commonwealth of Pennsylvania, known as the "Local Tax Enabling Act" (hereafter "LTEA"), authorizes certain political subdivisions to levy, assess and collect a tax on salaries, wages, commissions, compensation, net profits and earned income referred to as the "Earned Income Tax;" and

WHEREAS, Act No. 32 of the 2008 General Assembly of the Commonwealth of Pennsylvania, 53 P.S. §6924.501 et seq., (hereafter "Act 32") amended and restated the LTEA, wherein said Act 32 established entities known as a Tax Collection Districts (hereafter "TCD" for the purposes of county-wide collection of income taxes and other taxes. The geographic boundaries of a TCD shall be coterminous with the county in which it is created and shall consist of municipalities and school districts located within TCD; and

WHEREAS, Ferndale Area School District is located within the Cambria County TCD;

WHEREAS, Act 32 established tax collection committees (hereafter "TCC") wherein said TCCs would govern the TCDs pursuant to Act 32; and

WHEREAS, pursuant to Act 32, CCTCC was established to serve as the TCC for the Cambria County TCD; and

WHEREAS, the CCTCC has recommended to the municipalities and school districts within the Cambria County TCD that it update its current Earned Income Tax Resolution to reflect the changes set forth by Act 32; and

WHEREAS, FERNDALE AREA SCHOOL DISTRICT intends to update its current income tax Resolution to reflect the changes of Act 32; and

NOW THEREFORE, the Governing Body of FERNDALE AREA SCHOOL DISTRICT hereby ordains as follows:

Section 1. Authorization

This Resolution is enacted pursuant to the authority granted by the Local Tax Enabling Act, P.L. 1257, known as Act No. 511 of 1965, effective January 1, 1966, as thereafter amended through in Act 166 of 2002 and Act No. 32 of 2008, 53 P.S. Sec. 6924.101 et seq. (known as and herein referred to as the "LTEA"). The provisions contained herein are made for the purpose of amending and supplementing the Resolution adopted on June 30, 1981.

Section 2. Incorporation by Reference

The Governing Body of the FERNDALE AREA SCHOOL DISTRICT hereby adopts by reference the LTEA and the amended provisions of Act 32 (53 P.S. §6924.101 through 53 P.S. §6924.901) and its definitions, duties, directives, rules, regulations, powers and penalties as if same had been set forth fully herein.

Section 3. Imposition of Tax

A tax at the rate of one percent (1%) on each dollar is hereby imposed on all earned income and net profits, as defined by Act 32, earned by residents of the FERNDALE AREA SCHOOL DISTRICT. All changes shall remain in effect on a calendar year basis without annual reenactment unless the rate of tax is subsequently changed.

Section 4. Administration - Powers and Duties of Officer

The collection and administration of the tax provided for in this Resolution shall be performed by the Tax Officer appointed by the Cambria County Tax Collection Committee ("CCTCC"). Said Tax Officer shall receive such compensation for his services and expenses as determined from time to time by the CCTCC. Such Tax Officer shall have the powers and duties as provided for by Act 32 and the Local Tax Enabling Act.

Section 5. Severability

Should any section, subsection, sentence, clause or phrase of this Resolution be declared invalid by a Court of competent jurisdiction, such decision shall not affect the validity of the Ordinance in its entirety or of any part thereof other than that part declared to be invalid.
